

## PRIVACY POLICY

The personal information you provide us with will be included in a file called “E-mails File”, duly registered with the Data Protection Agency, which is the property and liability of BEVELAND, S.A., with its registered office at Calle Pladevall, número 13, Begudà - Sant Joan de les Fonts (17857) Girona.

For the above purpose, and in accordance with Royal Decree 1720/2007 of 21 December, BEVELAND, S.A. has adopted the appropriate security measures to protect the personal data you provide us with and has installed the technical means and measures to prevent the loss, improper use, alteration, unauthorized access and theft thereof.

On connecting to the <http://www.theglensilvers.com> website, the server where the website is hosted automatically recognizes the user's computer IP address and the day and time of their entering and exiting the site, as well as which website content the user has browsed. It is necessary for the BEVELAND, S.A. server to know all this data because it has to be able to communicate with the user in order to send them what they request via their browser so that they can view it on their screen. However, neither the server nor any member of BEVELAND, S.A. can know any of the user's personal data unless the latter freely and knowingly provides it.

In compliance with the above-mentioned regulations (Law on Personal Data Protection and Royal Decree approving the Regulations for the implementation of the Law on Personal Data Protection), we inform you that your personal data collected via the website, using forms or links to e-mail, will be processed for the purposes of managing potential customers, contacts and sales promotional initiatives, and may be stored in the corresponding files.
